In October 2000 a landmark document was adopted by the UN Security Council: UNSCR 1325 on women and peace and security. It highlighted the disproportionate impact of armed conflict on women, recognized their important role in the prevention and resolution of conflicts, and stressed the importance of women's full involvement in all efforts for the maintenance and promotion of peace and security.

With a view to a high-level review in 2015 to assess progress at the global, regional and national levels, and as a contribution to the Beijing+20 Campaign of UN Women, politicians and prominent activists will discuss significant achievements and major obstacles in the implementation of UNSCR 1325 and give their recommendations on how to achieve improved results in areas such as conflict prevention, management and resolution and participation of women in political processes.
